PRIVACY POLICY

We will only use data for the purposes for which it was collected and, where relevant, to meet any legal obligations. We will retain personal information associated with customer accounts for as long as you remain a customer of HC Innovations Ltd or as long as is required pursuant to law (e.g. account related information related to invoices/receipts).
